Sir,

In producing herewith arrested accused Asim Nandi(38) S/O-Khagen Nandi of Gopinathpur, PO-Telami, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Debprasad Samanta of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (26.05.17) at 20:05 hrs myself along with C/1641 Dilip Kr. Dhal, C/1664 Haripada Mahanty, C/1141 Bharat Ch. Ghosh all of Egra P.S vide C.C. No-1114/17 dt-26.05.17 as per secret source information reached at Gopinathpur under Egra PS and held raid in the house of Asim Nandi(32) S/O-Khagen Nandi of Gopinathpur, PO-Telami, P.S Egra, Dist-Purba Medinipur and found that he is selling country Spirit illegally. On being asked he failed to produce any valid documents/ license of the above mentioned possessed Country Spirit. On being asked the accused person stated that he is running this business since long having no valid license as well as She confessed her guilt.

Accordingly seized 07 (Seven) sealed bottles of Sun country Spirit each bottle contains 600 ml x 07=4200 ml and each bottle cost of Rs-65 x 07 = Rs 455/- (Rupees Four Hundred Fifty Five) only with one Nylon Bag as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry I have been learnt that the above noted accused person selling Country Spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Asim Nandi(32) S/O-Khagen Nandi of Gopinathpur, PO-Telami, P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act-1909 with a request for starting a case.
