Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Tapan Das, S/O- Lt Niranjan Das of Vill: Farakpara, P.O- Balighai, P.S Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 06.06.2017 at about 12.30 PM, I, Sri Soumen Mondal, Egra CCC, along with Sri Sasmal SAE (E), Egra CCC, Sri Bappa Mondal, T.S.H., Egra CCC and others had been to the Vill: Farakpara, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises of Sri Tapan Das, S/O- Lt Niranjan Das of Vill: Farakpara, P.O- Balighai, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Tapan Das; S/O- Lt Niranjan Das of Vill: Farakpara, P.O- Balighai, P.S-Egra, consuming electricity unauthorisedly by way of bypassing the energy meter by way of direct hooking from nearby LTOH in respect of Consumer Id No: 200665342, Meter No: TA048891 which is in the name of in view of less recording of unit or energy in to the energy meter causing loss of revenue to WBSEDCL in the tune of load 01.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 2 nos yellow colour PVC coated 4 sq mm aluminium conductor along with hooking device made as a sample were seized under memo of seizure in the presence of representative of the consumer i.e. Ratan Das, brother of Tapan Das and witnesses signed by them. Thereafter the seized articles were packed and labeled at the inspection site in the presence of Ratan Das, brother of Tapan Das and witness and signature of witnesses and representative of consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01.00 PM.

Thus Sri Tapan Das, S/O- Lt Niranjan Das of Vill: Farakpara, P.O- Balighai, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
