Sir,

In producing herewith the arrested accused (i)Sk Kalu(50) S/O- Lt. Sk Samiruddin of Bathuary, (ii)Sk Jahangir(30) S/O-Sk. MD Yusuf C/O-Sk Safiruddin of Bathuary, PS-Egra, Dist-Purba Medinipur along with seizure list, seized articles, arrest memo. I SI Bibek Banerjee of Egra PS do hereby lodge a complaint against the above noted arrested accused persons. I am to report that on 15.06.17 at about 00:45 hrs received an information from my reliable source that 8/10 miscreants have been assembled at back side of Dakshinbar primary school under this PS jurisdiction in a suspicious manner and they may commit dacoity near by village. Myself along with force C/468 Sandip Maity, C/1631 Saroj Talukdar vide Egra PS CC No-1321 date 14.06.17 left for workout the information. I also informed another mobile party headed by SI Debprasad Samanta with force C/577 Pintu Issu, C/323 Dilip Kr. Duley & C/1276 Chandan Das Vide Egra PS CC No 1322 Dated 14.06.17 who is also engaged night mobile duty to move towards Daxinbar. We used PS vehicle No-WB-42S/1500 and Vehicle No- WB-29/5034 (1/2 Toner) and reached at Dakshinbar at 01:35 hrs(15.06.17) and then we rushed to Dakshinbar keeping the vehicles in a safe distance as per source and found from a distance some persons were assembled and talking in a low voice. We try to asked local villagers and the local villagers came to the spot. Then we police party gheraowed those persons, finding the police personnel they tried to flee away but we managed to apprehend the above 02(Two) persons. On being asked they failed to give any satisfactory answer regarding their presence at that midnight. I conducted search in presence of accompanying police personnel's and local villagers, during search one 12 inches Bhojali has been recovered in the possession of Sk Jahangir and one 30 inches sabal has been recovered in possession of Sk Kalu some persons disappeared in the darkness. On being asked they disclosed their identify who managed to escaped (i)Uttam Maity of Egra (ii) Sk Nabius of Hurkuchia both of Dist-Purba Medinipur (iii)Sk Jakir of Jahalda (iv)Sk Azad of Belda both of Dist-Paschim Medinipur.

During interrogation the above noted accused persons confessed that they were assembled there with a view to commit house dacoity in near by village. I seized the offending weapons under proper seizure list and labeled properly duly signed by the witnesses. I took them in my custody and also prepared arrest memo and inform them ground of arrest and produced before you with a prayer to start a case U/S-399/402 IPC against the following accused persons namely (i)Sk Kalu(50) S/O- Lt. Sk Samiruddin of Bathuary, (ii)Sk Jahangir(30) S/O-Sk. MD Yusuf C/O-Sk Safiruddin of Bathuary (iii) Uttam Maity of Egra (iv) Sk Nabius of Hurkuchia all of PS-Egra, Dist-Purba Medinipur (v)Sk Jakir of Jahalda (vi)Sk Azad of Belda both of Dist-Paschim Medinipur and others.
