Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Sankar Maity, S/O - Gangadhar Maity, a permanent resident of Vill-Rajendrachak (Nawgharia), P.O -Keutgeria, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 14.06.2017 at about 01:05 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, all are of (S&LP)unit Contai Division Office along with Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Kalipada Rana, TSH, Egra CCC, Sri Bikash Maity, LM, Egra CCC and others had been to the village- Rajendrachak (Nawgharia) for routine inspection purpose. During inspection it was found that Sri Sankar Maity was consuming electricity dishonestly in his Commercial premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 01 (one) number separated single core yellow colour PVC coated 10 sq mm aluminium conductor causing considerable loss of revenue of WBSEDCL to the tune of load 1.76 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 01 (one) number separated single core yellow colour PVC coated 10 sq mm aluminium conductor of length 03 (three) meter (approx) along with hooking device as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Ranjan Mondal S/O- Kalipada Mondal a permanent resident of Vill- Uttar Padma under PS- Egra is an employee as well as representative of the accused was present at the inspection site and acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:30 PM.

Thus the accused Sri Sankar Maity, S/O - Gangadhar Maity, Vill - Rajendrachak (Nawgharia), P.O -Keutgeria, , P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
