S.I Krishnendu Pradhan, O/C Egra PS do here by lodge complaint as Suo Moto against Pradip Dey (40) S/O Narayan Chandra Dey of Negua, PS Egra, Dist. Purba Medinipur, who was stacking building materials and other articles i.e (Bricks, sand & stone chip, etc) by the side of Egra - Ramnagar road in front of the house of the above noted person by the side of said pitch road under mouja Negua, PS Egra, which was abstracted the said road.

The fact of the case in brief is that on 23.06.2017 at 10:05hrs in course of my mobile duty I noticed that some person is staking the building materials for contraction of his new building and keeping the materials at one side of the state High way on Egra - Ramnagar pitch road at Negua, which is obstructing the public way and as a result the road was becoming narrower, which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same. I took photograph of such illegal work.

On enquiry it could be learnt that one Pradip Dey (40) S/O Narayan Chandra Dey of Negua, PS Egra, Dist. Purba Medinipur, He is stacking the building materials like stone chips, sand for contraction of a new building at Negua by the side of Egra - Ramnagar Pitch road at Negua. Which was obstructing the roads and indanger human life of the public. He had violated section - 283/336 Indian Panel Code.

I examined so many villagers and took photograph of the place, but it was impossible to seize those huge quantity of materials, I have no man power or JCB for the removal work at that time. I seized some metrial articles ans sample duly signed by the witness.

So, I do lodge complaint as suo-moto against Pradip Dey (40) S/O Narayan Chandra Dey of Negua, PS Egra, Dist. Purba Medinipur, and start a case U/S - 283/336 IPC for investigation and endorsed to ASI Asim Kumar Maity will investigation the case.
