S.I Krishnendu Pradhan, O/C Egra PS do here by lodge complaint as Suo Moto against Siddheswar Jana S/O Lt. Jogendra Jana of Mirjapur, PS Egra, Dist. Purba Medinipur, who was stacking materials and other articles "Garbage" on the road side, on Ramnagar - Egra road in front of the house of the above noted person which is obstructing the portion public way rashly and negligently as to on danger human life as the personal safety of the public.

The fact of the case in brief is that on 23.06.2017 at 10:55hrs in course of my mobile duty I noticed that some person is ruing Garbage storing and suppling business and keeping the Garbage at one side of the state High way at Mirjapur, on Ramnagar - Egra road which is obstructing the public way and as a result the road was becoming narrower which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same. I took photograph of search illegal work.

On enquiry it could be learnt that one Siddheswar Jana S/O Lt. Jogendra Jana of Mirjapur, PS Egra, Dist. Purba Medinipur, was running this business of "Garbage" and keeping the said materials on the road side of Ramnagar - Egra Pitch road. Which was obstructing the roads and on danger human life of the public. He had violated section - 283/336 Indian Panel Code.

I examined so many villagers and took photograph of the place, so I have used JCB machine and removed the Garbage from the path way for safety of public. I have seized some materiel as sample duly signed by the witness.

So, I do lodge complaint as suo-moto against Siddheswar Jana S/O Lt. Jogendra Jana of Mirjapur, PS Egra, Dist. Purba Medinipur, and start a case U/S 283/336 IPC for investigation and endorsed to ASI Asim Kumar Maity will investigation the case.
