I S.I Krishnendu Pradhan, O/C Egra PS do here by lodge complaint as Suo Moto against Jayanta Senapati S/O Lt. Janardan Senapati of Chorpalia, PS Egra, Dist. Purba Medinipur, who was stacking the wooden logs and other Wooden articles on the road side, on Egra - Ramnagar road by the side the said pitch road. Which is obstructing the portion public way rashly and negligently as to on danger human life as the personal safety of the public.

The fact of the case in brief is that on 23.06.2017 at 13:25hrs in course of my mobile duty I noticed that some person is running wooden business of supplying the wood and keeping the said wood by the side of the state High way at Chorpalia, on Egra - Ramnagar road which is obstructing the public way and as a result the road was becoming narrower which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same. I took photograph of search illegal work.

On enquiry it could be learnt that one Jayanta Senapati S/O Lt. Janardan Senapati of Chorpalia, PS Egra, Dist. Purba Medinipur, is running his business of supplying Wooden Log and keeping those wooden log by the side of Egra - Ramnagar Pitch road. Which was obstructing the roads and on danger human life of the public. He had violated section - 283/336 Indian Penal Code.

I examined so many villagers and took photograph of the place, so I have used JCB machine and removed the wooden logs from the path way for safety of public. I have seized some materiel as sample duly signed by the witness.

So, I do lodge complaint as suo-moto against Jayanta Senapati S/O Lt. Janardan Senapati of Chorpalia, PS Egra, Dist. Purba Medinipur, and start a case U/S 283/336 IPC for investigation and endorsed to ASI Asim Kumar Maity will investigation the case.
