I A.S.I Achin Niyogi of Egra PS do here by lodge complaint against Pranay Pradhan S/O Lt. Bhuban Pradhan of Chorpalia, PS Egra, Dist. Purba Medinipur, from Egra - Ramnagar pitch road one side of mouja Chorpalia, under PS Egra, obstructing the public way who was stacking building materials and other articles (Sand & stone chip, etc) on Egra - Ramnagar road in front of the house of the above noted person which is obstructing the portion public way rashly and negligently as to on danger human life as the personal safety of the public.

The fact of the case in brief is that on 23.06.2017 at 10:55 hrs in course of my mobile duty I noticed that some person is staking the building materials for contraction of his new building and keeping the materials at one side of the state High way on Egra - Ramnagar pitch road at Chorpalia, which is obstructing the public way and as a result the road was becoming narrower, which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same. I took photograph of such illegal work.

On enquiry it could be learnt that one Pranay Pradhan S/O Lt. Bhuban Pradhan of Chorpalia, PS Egra, Dist. Purba Medinipur, He is stacking the building materials like stone chips & sand for the contraction of a new building at Chorpalia by the side of Egra - Ramnagar Pitch road at Chorpalia. Which was obstructing the roads and endanger human life of the public. He had violated section - 283/336 Indian Penal Code.

I examined so many villagers and took photograph of the place, I have used JCB machine and removed the building materials from the path way, for the safety I seized some materials articles and sample duly signed by the witness.

So, I do lodge complaint against Pranay Pradhan S/O Lt. Bhuban Pradhan of Chorpalia, PS Egra, Dist. Purba Medinipur, for starting a case U/S - 283/336 IPC.
