I A.S.I Achin Niyogi of Egra PS do here by lodge complaint against Sunil Manna(45) S/O Lt. Dibakar Manna of Bil Choulda, PS Egra, Dist. Purba Medinipur, from Egra - Ramnagar pitch road one side of mouja Chorpalia, under PS Egra, obstructing the public way who was stacking soil and mud in front of the shop on Egra - Ramnagar road in front of the house of the above noted person which is obstructing the public way rashly and negligently as to on danger human life as the personal safety of the public.

The fact of the case in brief is that on 23.06.2017 at 13:15 hrs in course of my mobile duty I noticed that some person is staking soil and mud in front of their house of the above noted person and keeping the same at one side of the state High way on Egra - Ramnagar pitch road at Chorpalia, which is obstructing the public way and as a result the road was becoming narrower, which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same. Today an accident took place at that place, due to said stacking, over this one person injured and shifted to Egra S.D Hospital. I took photograph of such illegal work.

On enquiry it could be learnt that one Sunil Manna(45) S/O Lt. Dibakar Manna of Bil Choulda, PS Egra, Dist. Purba Medinipur, He is stacking soil and mud for the contraction of a building works at Chorpalia by the side of Egra - Ramnagar Pitch road at Chorpalia. Which was obstructing the roads and endanger human life of the public. Today injured person expired at S.D Hospital and over this Egra PS Case No 342/17 dtd.- 23.06.2017 U/S 279/304A IPC. So he had violated section - 283/336 Indian Panel Code.

I examined so many villagers and took photograph of the place, I have used JCB machine and removed the soils from the path way, for the safety I seized some materials articles and sample duly signed by the witness.

So, I do lodge complaint against Sunil Manna(45) S/O Lt. Dibakar Manna of Bil Choulda, PS Egra, Dist. Purba Medinipur, for starting a case U/S - 283/336 IPC.
