Sir,

In producing herewith arrested accused Manisankar Mandal(37) S/O-Lt. Chaturbhuj Mandal of Khurutia, P.S -Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I ASI Asim Kr. Maity of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (24.06.17) at 20.45 hrs myself along with C/151 Nazrul Hossain, C/747 Pranajit Dey and NVF SK Ekram all of Egra P.S vide C.C. No-1432/17 dt-24.06.17 as per secret source information reached at Paniparul under Egra PS and held raid in the betet shop of Manisankar Mandal(37) S/O-Lt. Chaturbhuj Mandal of Khurutia, P.S -Egra, Dist-Purba Medinipur and found that he is selling Sun country Spirit illegally. On being asked he failed to produce any valid documents/ license of the above mentioned possessed Sun Country Spirit. On being asked the accused person stated that he is running this business since long having no valid license as well as he confessed his guilt.

Accordingly seized 06 (Six) sealed bottles of Sun country Spirit each bottle contains 600 ml x 06=3600 ml and each bottle cost of Rs-65 x 06 = Rs 390/- (Rupees Three Hundred ninety) only with one Nylon Bag as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry I have been learnt that the above noted accused person selling Sun Country Spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Manisankar Mandal(37) S/O-Lt. Chaturbhuj Mandal of Khurutia, P.S -Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act-1909 with a request for starting a case.
