Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Radha Krishna Pradhan, S/O- Lt Ram Chandra Pradhan of Vill: Jinandapur, P.O- Balagaria, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 03.07.2017 at about 12.15 PM, I, Sri Soumen Mondal, Egra CCC, along with Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Bikash Maity, LM., Egra CCC and others had been to the Vill: Jinandapur, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Radha Krishna Pradhan, S/O- Lt Ram Chandra Pradhan of Vill: Jinandapur, P.O- Balagaria, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Radha Krishna Pradhan, S/O- Lt Ram Chandra Pradhan of Vill: Jinandapur, P.O- Balagaria, P.S-Egra, Dist-Purba Medinipur, consuming electricity unauthorisedly by way of direct hooking from nearby LTOH of WBSEDCL, causing loss of revenue to WBSEDCL in the tune of load 0.6 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 black colour PVC coated 2 core 6 sq mm alluminium cable alongwith hooking device were seized under memo of seizure list in presence of the consumer and witnesses duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 12.45 PM.

Thus Sri Radha Krishna Pradhan, S/O- Lt Ram Chandra Pradhan of Vill: Jinandapur, P.O- Balagaria, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
