Dear Sir

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Ajabul Khan, S/O- Esabuddin Khan of Vill: Purusottampur word no-08, P.O. Egra, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 30.01.2017 at about 01:05 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with Sri Sump Sengal, SAE(E), Egra CCC, Sri Bikash Maity, LM Egra CCC and others had been to the Vill: Purusottampur word no-08, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises of Sri Ajabul Khan, S/O- Esabuddin Khan of Vill: Purusottampur word no-08, P.O- Egra, P.S-Egra, Dist Purba Medinipur and during inspection it was found that Sri Ajabul Khan, S/O- Esabuddin Khan of Vill: Purusottampur word no-08, P.O- Egra, P.S-Egra, Dist-Purba Medinipur consuming electricity dishonestly by way of bypassing the energy meter through incoming terminal of energy meter consumption through the energy meter unauthorisedly in respect of Consumer Id No: 223050462, Meter No: ML167109, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from the pole and some portion of 2 (two) number separated single core, white colour PVC coated 2.5 sq mm copper conductor of length 1 (one) meter each approx along with one setting switch board used to run the electrical appliances unauthorisedly of domestic purpose were seized under memo of seizure list in presence of consumer but refused to sign and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of the consumer but refused to sign and affix seal and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:30 PM.

Thus Sri Ajabul Khan, S/O- Esabuddin Khan of Vill: Purusottampur word no-08, P.O- Egra, P.S-Egra, Dist Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
