Sir,

In producing herewith 01 (One) arrested male accused person namely Bibhuti Das, S/O-Lt. Pulin Das of Aklabad, Ward No-10.P.S- Egra, Dist-Purba Medinipur in custody under proper Memo of Arrest of seized Captain Nimbu Country Sprite as per seizure list duly signed by witnesses and accused person. I, ASI Ashim Kumar Maity of Egra PS do hereby lodge a complaint as Suomoto after returning at PS, to the effect that today (02.02.17) at 17:45 hrs myself along with C/ 1661 Dilip Kr. Dhal, C/1631 Saroj Talukder and NVF SK Rabuil all of Egra PS in course of Evening Mobile Duty vide C.C. No-269/17 dt-02.02.17 as per secret source information reached at Purusottampur, Ward No-8, under Egra PS and holding raid in the hotel cum shop of Bibhuti Das S/O-Lt. Pulin Das of Purusottampur, Ward No-8, P.S- Egra who was selling Captain Nimbu Country Sprite illegally. On being asked he failed to produce any valid documents / license of the above mentioned possessed liquor and on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I seized (i) Captain Nimbu Country Sprite 10 (ten) sealed bottles per bottle 600 ml x 10 = 6000 ml and each bottle Rs-55/- x 10 =550/- (Rupees five Hundred fifty) only as per seizure list duly singed by witnesses and accused person. I arrested the above noted accused person with proper arrest rule after issuing memo of arrest. Before arrest I informed him the ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country Sprite since long.

So I do hereby lodge a written complaint against above mentioned namely Bibhuti Das, S/O-Lt. Pulin Das of Aklabad, Ward No-10.P.S- Egra, Dist-Purba Medinipur for violation of Act U/S-46 A of Bengal Excise Act,-1909. Requesting O/C Egra PS for starting a case.
