Subject : Prayer for treating the instant complaint as an F.I.R. under  
sections 406,409, 420,120B, of the Indian Penal Code.

Sir,

I being the President of the Egra Jhatulal High (H.S.) School beg to inform you that a resolution was adopted by the Managing Committee empowering the undersigned to lodge a complaint against the Headmaster of the present school on the basis of a report of the Sub divisional Officer, Egra, Purba Medinipur, dated 20.01.2017.

That the Headmaster of the present school has misappropriated huge amount of money in running of the Mid Day Meal of the present School as well as amount which was collected towards donation in favour of the school, or got from Govt. allotted funds in both general and Vocational streams was also either misappropriated or not deposited in the School Fund Account. The complaint was lodged by some vendors stating to the effect that although they supplied the materials for the Mid Day Meal of the School and issued vouchers to the Headmaster for making payment of the materials supplied, but they did not get the full amount from the end of the Headmaster. However, on the basis of that complaint inquiry was initiated by the Sub-divisional Officer, Egra and upon holding of detailed inquiry, it is revealed that the Headmaster of the present school has taken the amount towards running of the Mid Day Meal from the School Account by way of issuing cheque along with the signature of the Secretary though the Secretary has got no fault as he issued the cheques duly signed by him on the basis of the vouchers produced before him by the Headmaster and those cheques were placed before the Bank and amount was withdrawn, but the amount was not ultimately paid to the vendors for supplying materials for running of the Mid Day Meal in the school. As a result whereof from the inquiry report it is revealed that the amount was misappropriated by the Headmaster of the present school for running of the Mid Day Meal.

However, some donations were collected from the outsiders and that donation amount was also not deposited in the School Fund and the resolution was adopted to the effect according to his confession that the amount of Rs. 2,50,000/- is lying with him(Headmaster) in his hand. As per the provisions of the school code, the Headmaster is entitled to retain cash of Rs.1200/- only in his own hand. Therefore, the entire amount which was taken by the Headmaster in running the Mid Day Meal of the school and the amount that was collected towards the donation of the school and was not deposited in school's account amounts to misappropriation of the School Fund. It is made clear that the Headmaster in his capacity as a public servant has misappropriated the amount of the School Fund and thereby he has committed offences punishable under section 406,409,420,120B, of the Indian Penal Code.

That the inquiry report as well as the resolution as annexed herewith clearly reveal that the Headmaster, in fact, has misappropriated the amount and thereby he is liable to be prosecuted under the above mentioned sections of law.

In view of the above scenario, I inform you to take steps on the basis of the present complaint and to treat the same as F.I.R. under the above mentioned sections so that the Headmaster can be prosecuted under the appropriate sections of law in this respect. I would like to inform you that you being the appropriate authority should take proper steps on the basis of the complaint immediately that is within ten days from the date of receiving of this complaint.
