Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sk Safiruddin, S/O- Lt Sk Moinuddin of Vill: Purusottampur, Ward No-08, P.O- & P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act, 2007 as stated hereunder.

On 23.12.2016 at about 03:30 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC along with Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, Sri Bikash Maity, LM Egra CCC and others had been to the Vill: Purusottampur, Ward No-08, P.S.-Egra for routine inspection purpose. At first we went to the Domestic premises Sk Safiruddin, S/O- Lt Sk Moinuddin of Vill: Purusottampur, Ward No-08, P.O- , P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Sk Safiruddin, S/O- Lt Sk Moinuddin of Vill: Purusottampur, Ward No-08, P.S-Egra, Dist-Purba Medinipur consuming electricity dishonestly by way of direct hooking through 1 (one) number single core, black colour coated 2.5 sq mm copper conductor for bypassing the energy consumption through the energy meter unauthorisedly in respect of Consumer Id No: 223032465, Meter No: L064625, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from the pole and some portion of 1 (one) number single core, black colour coated 2.5 sq mm copper conductor of length 3 (three) meter approx along with hooking device used to run the electrical appliances unauthorisedly of domestic purpose was seized under memo of seizure list in presence of Najir Ali Khan S/O- Lt. Kalu Khan (who is the brother of the consumer) and witnesses. Najir Ali Khan S/O- Lt. Kalu Khan was present at the spot during inspection but refused to sign. Thus signature of witnesses was duly done on the same. Thereafter the seized articles were packed and labeled at the inspection site in presence of representative of the consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 04:00 PM.

Thus Sk Safiruddin, S/O- Lt Sk Moinuddin of Vill: Purusottampur, Ward No-08, P.O- , P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
