Sub - Complaint / FIR lodge against - Jotirmoy Das Mahapatra, S/o Jasoda nandan Das Mahapatra And Shila Das Mahapatra, W/o- Late Supriyo Das Mahapatra, both are resident of Vill.- Nayagaon, P.O.- Paroi, P.S.- Mohanpur, Dist.- Paschim Medinipur. Pin.- 721436

Respected Sir,

I smt. Dipali Das mahapatra, aged about - 42 years W/o- Bidhan Kumar Das Mahapatra At/ Po. - Panchrol, Ps. - Egra, Dist. - Purba Medinipur, Pin. - 721447 , West Bengal begs tostate that:

1. That, my elder sister smt. Shila Das Mahapatra ,W/o - Late Supriyo Das Mahapatra along with her father- in-law Jotirmoy Das Mahapatra showing with a good faith,trust and believe one day came to my house addressed mentioned above , with a malafide intention, involved / implicate me along with may husband , said that we will appoint with a free of cost (you don't have to pay any money) Dipali for the post of (Primary Tet)& S.S.C and Orgniser Teachers (Primary) , if your husband help us to provide few candidates for the said post and with regard to the said post we need Rs. 7,000.00/- (Rupees seven lakh) only per candidate.

2. That, inspite of strict rejection and denied to involved in that grumbling matter , my elder sister and her father in law imotionlly black - mailed me time and again , pretend and attracted us to give me that job, with a drak / false promise. As my husband denied / not agreed with that promise , said he is a government employee and instructed me not to involve in the said matter but latter on they forced me to convince my husband to arrange candidates for the said post mentioned above.

3. That, Jotirmoy Das Mahapatra again deceived us thourgh Kingshuk Das (mediator) , S/o- Late Ajit Das resident of Agarbwara, P.O.- Paroi , P.S. - Mohanpur, of Pachim Medinipur is working in Budget Section , of Education Department at Bikash Bhavan Salt lake, West Bengal and he has good connec- tion with one named Manik Bttacharya President of West Bengal of Primary Education and said through these people we can successfully appoint the candidates , you both husband and wife need not to be worried for the said matter

4. That, with the conspricy, concealment of Jotirmoy Das Mahapatra, candidates came directly to me and in may present few number of candidates paid an amount Rs.- 8,95000/- (Eighty Lakh Ninty Five Thousand Rupees) only to Jotirmoy Das Mahapatra in my house / resident in the presence of my husband and Jotirmoy Das Mahapatra creating with a high leval of faith, trust and believe promised to the candi- dates to give jobs as soon as possible

5. That in the process of cheating and impersonation Jotirmoy Das Mahapatra since the year 2012 to 2014 has taken an amount **Rs. 56.50/- (fifty six lakhs and fifty thousand rupees only)** on different dates. With regard the said amount I have possessed a copy as an evidence in which Jotirmoy Das Mahapatra made his signature on dated 06.09.2013 in the presence of Sila Das Mahapatra and his grand daughter Anuradha Das Mahapatra.

6. That,it is also found that a racket of mal- practised people along with high influencial people of society working with Jotirmoy Das Mahapatra to cheat / deceive people with a false, fabricated intention to provide jobs to different candidates of different regions in the state of West-Bengal .

7. That, the intention of Jotirmoy Das Mahapatra is to grab / exploit money with high - handedness

8. That it is also found that to deceive and cheat the people of West Bengal and out side of the State in the Country created a false and fake website in the name West Bengal Board of Primary Education to provide jobs and apointment to different candidates in the state and latter on with all evidence it is found that the internet site is completly is false, fabricated and whimschal .

9. That, it is also found that Jotirmoy Das Mahapatra made false signatures in affidavits before the Notary Public of Kolkata, for the purpose of providing jobs to candidates as impersonation in the name of Sougato Nandy, Avijit Mandal and Satish Kumar Maity which need to be punished in the eyes of law

10. That, as a relative of me and my husband I tried time, again and agin to recollect / recevie the said money which has taken by Jotirmoy Das Mahapatra and in the processes Jotirmoy Das Moahapatra paid me personally of Rs. 14.75/- (Rupees fourteen Lakh and Seventy Five Thoudand only) to which people of named : 1. Soumen Das (Dipu), 2. Ranjan Das (Bappa) . 3. Khalil Mallick, 4. Ansuman Pattanayak, 5. Bikash are witnesses to this matter and till date since the year 2016, many a times again and again personally me and with the mediators I requested Jotirmoy Das Mahapatra to give my rightful / justified money to which I have to pay the candidates who applied for jobs to be paid by me but Jotirmoy Das Mahapatra now denided to pay a single pie of money to me and saying that he does not know me and he will not pay any money to the candidtates who paid the said amount toJ otirmoy Das Mahapatra.

Therefore, not getting any ray of hope to get my demanded money for the candidtates, with a mental and physical torture from Jotirmoy Das Mahapatra forced to lodge this F.I.R against him before the concerned police authority and requeste yourself to take necessary , immediate steps as the due procedure of laws. Hence the matter is urgent to recover the said amount of money with interest, in the interest of justice. And for which I shall be as in bound pray.

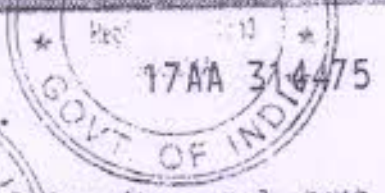
