My self SI Krishnendu Pradhan O/C Egra PS here by lodging Suo-Moto written complaint against the mike operator mike arranger and committee Saraswati puja at Balighai PS Egra who are plying loud speakers on the dead hrs. of night of 06/07.02.17 after 22:00 hrs to 01:50 hrs on the eve of Saraswati puja Festival with extreme loud sound through Festival but it is here from all most all the corner of Balighai village that after 23:00 hrs some "dhip dhip" sound with massive loud music of favorite film Chennai Express, Lungi Dance etc heard from this so called Saraswati puja organizers pandel. Peoples at all corners at the town clearly blaming the administration that the police and civil wings including the court affects and magistrates all are deaf and dumb they are not doing anything for the people though they are wholly responsible for this act or non acting as apart of their job of responsibility. Over that myself with SI Abhijit Patra, left PS and force vide Egra PS GDE No- 290 dt- 06.02.17 under Supervision of me left for Balighai to pursue and caring of the citizens (especially of children age old and patient) of Balighai. And we reached at Balighai Dry-fish Market on 07.02.17 at 00:55 hrs and found that a huge numbers of Box, Amplifier, Stangen, DVD are staged on some bamboo made lift on the Contai Belda pitch road at Balighai Dry-fish Market and the mike man plying the sound system in extreme loud position and even we cannot heard the conversation of each other.

It is reasonably observed that some members of Sarbajanin Sri Sri Saraswarti Puja, Yaba Sampraday, Mallickpur, Bottala, Balighai with mike man of concerned sound company created obnoxious situation at Balighai Dry-fish Market with loud speakers Box High Level DJ machine amplifier etc which irate the peoples of locally. A tension was being cropped up. I warn them to stop their activity but the members of said club became aggravate and obstruct the police party and started abuse langue pelting stone towards us how over we managed the situation and arrested one mike man Namely Ratan Kumar Mal (29) S/O Swapan Kumar Mal of village Tatkabad, PS Marisda, Dist- Purba Medinipur and others fladway.
