

Sir,

In producing herewith the accused (f) Subal Ch Poira S/O- Lt Gangadhar Poira of Aruya, PS-Egra (2) Chandan Poira S/O- Subal of do along with seizure list, seize articles, arrest memo. I SI Bibek Banerjee of Egra PS do hereby lodge a Suo-Moto complaint against the above noted arrested accused persons. I am to report that on 06.02.17 at about 22:55 hrs received a telephonic information from duty officer SI Deb Prasad Samanta vide Egra PS GDE No-287 dt-06.02.17 that some miscreants have been assemble at Ramchandrapur Canelparh and they are whispering in a low voice preparing to commit dacoity near by village. Accordingly I inform the matter to my superior officer. Having instructions myself along with, C/151 Sk. Nazrul Hossain, C/1193 Dilip Kr. Bar , NVF Srikanta Barik , vide Egra PS CC No 307/17 date 06.02.17 left for workout the information. I also informed another mobile party headed by ASI Tapas Das with force C/ 1631 Soraj Talukdar, C/468 Sandip Maity, C/1661 Dilip Dhal Vide Egra PS CC No 306/17 Dated 06.02.17 who are engaged 1st night mobile duty. We used PS vehicle No-WB42S-1500 and Vehicle No-WB30C-8489 and reached Ramchandrapur Canelparh on 07.02.17 at 00:25hrs and as called for my sources and then we had been Ramchandrapur Canelparh and found from a distance 06/07 persons were assembled and were talking in a low voice. We try to called local villagers, but the place is solitary and none found. Then we police party surrounded those persons finding the police personnel approaching towards them some of the accused fled away. We could apprehend the above 02 persons and conducted search in presence of accompany police personnel during search we find one Vojali about 12 " from the possession of Chandan Poira and one iron rod from the possession of Subal Ch Poira, 03 bottle of country liquor containing half in each bottle, 10 plastic glasses, some burn biri and cigarette and 04 pieces of candle, lighter also found the following articles from the spot and prepared seizure list of the articles. During interrogation the above noted accused persons confessed that they were assembled there and were preparing to commit house dacoity in near by village with the leadership of Ujjal Das S/O- Khudiram Das of Aruya PS- Egra. I prepared seizure list of those articles duly sign by the witnesses and also prepared arrest memo. Arrested the 02 accused persons and inform them ground of arrest.

Hence I request to start a case against the above noted accused persons under proper

section of law.
