the hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Biren Samanta, S/O- Lt Jhatu Samanta of Vill: Saharda, P.O- Erenda, P.S Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 06.02.2017 at about 1:20 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with, Sri Bikash Maity, LM Egra CCC, Subir Doloi Gr.1 TSH Egra CCC had been went to the Vill: Saharda, P.S- Egra for routine inspection purpose. At first we went to the Agricultural premises Sri Biren Samanta, S/O- Lt Jhatu Samanta of Vill: Saharda, P.O- Erenda, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Biren Samanta, S/O- Lt Jhatu Samanta of Vill: Saharda, P.O- Erenda, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking from the near by LTOL of WBSEDCL used to run agricultural pump motor set, causing loss of revenue WBSEDCL in the tune of load 2.00 HP.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 (one) number separated single core black colour PVC coated copper aluminium conductor of length 3 (three) meter approx along with hooking arrangement were seized. A seizure memo of seizure list in presence of consumer but refused to sign and witnesses duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer but refused to sign and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 1:45 PM.

Thus Sri Biren Samanta, S/O- Lt Jhatu Samanta of Vill: Saharda, P.O- Erenda, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
