Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Ratan Ojha, S/O- Lt Bankim Ojha of Vill: Chattri, P.O- Chattri, P.S- Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 08.02.2017 at about 12:30 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with, S. Bha. Maiti, LM Egra CCC, Subir Doloi Gr.1 TSH Egra CCC had been went to the Vill: Chattri, P.O- Chattri, P.S- Egra for routine inspection purpose. At first we went to the Agricultural premises Sri Ratan Ojha, S/O- Lt Bankim Ojha of Vill: Chattri, P.O- Chattri, P.S- Egra, Dist- Purba Medinipur and during inspection it was found that Sri Ratan Ojha, S/O- Lt Bankim Ojha of Vill: Chattri, P.O- Chattri, P.S- Egra, Dist- Purba Medinipur consuming electricity unauthorisedly by way of by the way of direct hooking from the near by DTR LT bushing used to run the agricultural pump motor set, causing loss of revenue to WBSEDCL in the tune of load 6.58 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from DTR LT bushing and some portion of 3 (three) number separated single core, one blue, one white and one fade red colour PVC coated 10 sq mm aluminium conductor of length 2 (two) meter each approx along hooking arrangement were seized under memo of seizure list in presence of consumer but refused to sign and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer but refused to sign and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:00 PM.

Thus Sri Ratan Ojha, S/O- Lt Bankim Ojha of Vill: Chattri, P.O- Chattri, P.S- Egra, Dist- Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.
