Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Srimanta Kumar Dinda, S/O - Lt Sribaprasad Dinda, a permanent resident of Vill-Purunda, P.O -Negua, P.S -Egra, Dist- Purba Medinipur Con id-223039764 has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 08.02.2017 at about 11.10 AM I, Sri Sudipta Rong, AE & SM of Chorepalia CCC, alongwith Sir Ratan Bhunia, SAE (E), Chorepalia CCC, Sri Raju Hazra LM, Chorepalia CCC and others had been to the village- Purunda for routine inspection purpose and found that Sri Srimanta Kumar Dinda, S/O - Lt Sribaprasad Dinda was consuming electricity avoid his energy meter(RSX27405) dishonestly in his Agricultural premises unauthorisedly by way of direct hooking from the nearby LT mains of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.39 KVA.

As theft of electricity was detected during inspection so the unauthorized line was disconnected & removed from our LT source and some portion of 3 (three) nos separated single core 04 sq mm, white,yellow and blue colour PVC coated aluminium conductor of length 2 (two) meter each approx along with hooking device were seized under memo of seizure list in the presence of witnesses of WBSEDCL respect person and their signature is also duly obtained in the seizure list. Sri Nimai Dinda representative of the accused was present during inspection and acknowledged the same by putting her signature on the Inspection report, Seizure List and label also. The above seized materials duly packed and labeled at the inspection site. After completion of inspection, the inspection team left the aforesaid premises at about 11.40 AM.

Thus the accused Sri Srimanta Kumar Dinda, S/O - Lt Sribaprasad Dinda, a permanent resident of Vill-Purunda, P.O -Negua, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (b) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
