Sir,

In producing herewith 01 (One) arrested male accused person namely Khokan Jana(39)S/O-Motilal of Palashi, P.S- Belda,Dist-Paschim Medinipur in custody under proper Memo of Arrest of seized Power Country Sprite and others alcohol as per seizure list duly signed by witnesses and accused person. I, SI D.P Samanta of Egra PS do hereby lodge a complaint as Suo - moto after returning at PS, to the effect that today (08.02.17) at 20:45 hrs myself along with C/618 Sankar Das, C/1102 Hakim Kisku ,C/847 Abdul Khalek Khan all of Egra PS in course of Evening Mobile/SPL Duty vide C.C. No-321/17 dt-08.02.17 as per secret source information reached at Egra Central Bus Stand, under Egra PS and holding raid in the Hotel Sutanuka owner of Khokan Jana S/O-Motilal of Palashi, P.S- Belda,Dist-Paschim Medinipur who was selling Power Country Sprite and others alcohol illegally. On being asked he failed to produce any valid documents / license of the above mentioned possessed liquor and on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I seized 1)09 bottles of power country sprite each bottles contain 600ml each bottle of Rs.55/-Total Rs.495/-(2)11 bottles of sun country sprite each bottle contain 600ml each bottle Rs.55/-Total Rs.605/-(3) 06 bottles Hayward 5000/- super strong beer is bottle contain 650 ml and each Rs. 85/- total Rs 510/- (4)13 bottles of Medowells No 01 XXX rum each bottle contain 180ml and each bottle Rs. 90/- Total Rs.1170/-, (05)03 Bottles of do each bottle contains 375ml and each bottle Rs.180/-Total Rs. 540/-(06)15 bottles of Officers Choice whisky each bottle contain 180ml and each bottle of Rs.100/-Total Rs.1500/- Total value Rs. 4820/-(Four thousand eight hundred twenty rupees only). I arrested the above noted accused person with proper arrest rule after issuing memo of arrest. Before arrest I informed him the ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country Sprite and others alcohol since long.

So I do hereby lodge a written complaint against above mentioned namely Khokan Jana(39)S/O-Motilal of Palashi, P.S- Belda,Dist-Paschim Medinipur for violation of Act U/S-46 A of Bengal Excise Act.-1909. Requesting O/C Egra PS for starting a case.
