Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri sk. Jahangir Hossain, S/O- Lt Murtaj Ali of Vill: Dakhinbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.02.2017 at about 12:20 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC along with Sri Bikash Maity, LM Egra CCC, Sri Bappa Mondal, TSH Egra CCC and others had been to the Vill: Dakhinbar, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri sk. Jahangir Hossain, S/O- Lt Murtaj Ali of Vill: Dakhinbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri sk. Jahangir Hossain, S/O- Lt Murtaj Ali of Vill: Dakhinbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur consuming electricity dishonestly by way of direct hooking from the near by LTOH line of WBSEDCL unauthorisedly use to run the domestic appliances, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 (one) number single core black colour PVC coated 4 sq mm aluminium conductor of length 2 (two) meter approx along with hooking device used to run the electrical appliances unauthorisedly of domestic purpose were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 12:40 PM.

Thus Sri sk. Jahangir Hossain, S/O- Lt Murtaj Ali of Vill: Dakhinbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.
