Sir,

I ASI Tapas Kr. Das do here by lodge the complain against (i) Mantu Jana (56), S/O-Lt. Kedar Jana of Bilbora, PS- Egra to the effect that The fact of the case is that today (16.02.17) at about 18:15 hrs I received a secret source information that one Mantu Jana (56), S/O-Lt. Kedar Jana of Bilbora, PS-Egra at Panchrole Bazar is selling ID and Foreign liquor illegally from his shop at Panchrole Bazar with out any license. Accordingly I inform O/C Egra PS and as per order OC Egra PS myself along with C/401 Prabir Das, C/323 Dilip Kr. Duley, and NVF Sk. Ekram held raid of the said shop. On seeing the Police party the said accused person along with other fled away. During search I seized 5(Five) Liters of ID Liquor , 6 (Six) bottle of sun Country sprit each bottle contain 600 ml and Mc Dwell Rum 4(Four) bottle of each bottle contain 180 ml under proper seizure list from his shop.

On enquiry it is learnt that the said Mantu Jana is running this illegal business from his shop since long without any valid license.

So I do hereby lodge a written complaint against above noted person namely Mantu Jana (56), S/O-Lt. Kedar Jana of Bilbora, PS-Egra, Dist- Purba Medinipur for violation of Act U/S-46 A(C) of Bengal Excise Act.-1909. Requesting O/C Egra PS for starting a case.
