Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Soumen Maity, S/O- Lt Mangobinda Maity of Vill: Hatbaincha, P.O- Hatbaincha, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.02.2017 at about 1:35 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC along with Sri Sudip Sasmal SAE(E) Egra CCC, Sri Bikash Maity, LM Egra CCC, and others had been to the Vill: Hatbaincha, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Soumen Maity, S/O- Lt Mangobinda Maity of Vill: Hatbaincha, P.O- Hatbaincha, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Soumen Maity, S/O- Lt Mangobinda Maity of Vill: Hatbaincha, P.O- Hatbaincha, P.S-Egra, Dist-Purba Medinipur consuming electricity dishonestly by way of direct hooking from the near by LTOH line of WBSEDCL unauthorisedly use to run the domestic appliances, causing loss of revenue to WBSEDCL in the tune of load 1.65 KVA.

As theft of electricity was detected during the inspection the illegale hooking line was disconnected from pole and some portion of 2 (two) number separated single core green colour PVC coated 4 sq mm aluminium conductor of length 3 (three) meter approx along with hooking device were seized under memo of seizure list in presence of consumer but he with local witness refused to sign. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer but he with local witness refused to sign and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 2:00 PM.

Thus Sri Soumen Maity, S/O- Lt Mangobinda Maity of Vill: Hatbaincha, P.O- Hatbaincha, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
