Sir,

In producing herewith 01 (One) arrested male accused person namely Dinesh Sahoo(48) S/O-Lt. Kalicharan Sahoo of Paniparul, P.S- Egra, Dist- Purba Medinipur in custody under proper Memo of Arrest of seized selling ID liquor Sprite as per seizure list duly signed by witnesses and accused person. I, SI Deb Prasad Samanta of Egra PS do hereby lodge a complaint as Suo - moto after returning at PS, to the effect that today (17.02.17) at 19:45 hrs myself along with C/ 618 Sankar Das, C/1102 Hekim Kisku and C/1193 Dilip Kr. Bar all of Egra PS in course of Evening Mobile Duty vide C.C. No-406/17 dt- 17.02.17 as per secret source information reached at Paniparul under Egra PS and holding raid in the hotel cum shop of Dinesh Sahoo(48) S/O-Lt. Kalicharan Sahoo of Paniparul, P.S- Egra who was selling ID liquor illegally. On being asked he failed to produce any valid documents / license of the above mentioned possessed liquor and on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I seized (i) 05 (five) Lts I.D liquor containing in a plastic jerrican Rs-100/- x 05 =500/- (Rupees five Hundred) only as per seizure list duly signed by witnesses and accused person. I arrested the above noted accused person with proper arrest rule after issuing memo of arrest. Before arrest I informed him the ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized article.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country Sprite since long.

So I do hereby lodge a written complaint against above mentioned namely Dinesh Sahoo(48) S/O-Lt. Kalicharan Sahoo of Paniparul, P.S- Egra, Dist-Purba Medinipur for violation of Act U/S-46 (C) of Bengal Excise Act.- 1909. Requesting O/C Egra PS for starting a case.
