Sir,

In producing herewith 01 (One) arrested male accused person namely Sambhu Jana @ Sona(38) S/O-Amullya Jana of Kasba Egra, Ward No-14, P.S Egra, Dist-Purba Medinipur in custody under proper memo of arrest & seized country spirit as per seizure list duly signed by witnesses and accused. I ASI Achin Neyogi of Egra P.S do hereby lodge a complaint as Suo - moto after returning at P.S to the effect that today (19.02.17) at 08:15 hrs myself along with C/151 Nazrul Hossion, C/577 Pintu Issu & NVF Rabiul Hossion all of Egra P.S vide C.C. No 418/17 dt-19.02.17 as per secret source information reached at Solpatta Bus Stand, Kasba Egra and held raid in the shop of Sambhu Jana @ Sona and found that he was selling Country Spirit illegally. On being asked the above noted accused person failed to produce any valid documents/license of the above mentioned possessed Country Spirit and disclosed his name & also asked before me he is selling illegal liquor since long.

Accordingly I have seized the following country spirit as per seizure list properly duly signed by witnesses. I have arrested the above noted accused person and during arrest asked him the ground of arrest and took his signature in the arrest memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person illegally selling country spirit since long. I seized 10 pieces sealed bottle of country spirit branded as Sun. 10 pieces sealed bottle (600 ml per bottle) X Rs 55/-total cost of Rs 550/- (Rupees Five hundred Fifty) only.

So, I do hereby lodge a written complaint as Suo-moto against above mentioned Sambhu Jana @ Sona(38) S/O-Amullya Jana of Kasba Egra, Ward No-14, P.S-Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
