Subject:- First Information Report on Physical Assault and Life Threat.

Sir.

It is for your kind information that on 07.02.2017 at around 1600 Hrs. while I was returning from my native place by my car No. WB20Z 3809, a car bearing No. WB30N 1868 from the opposite side was trying to overtake a bus from the same direction and broke my right side looking glass at a very high speed. I was frightened but continued to my destination CPT Township. When I entered township through the gate nearby St. Xavier's school, the same car came to my right side and hit my right side rear door and stopped in front of my car and blocked my road ahead. The driver from the said car came out and taken out my car's ignition key and dragged me out from my car by holding the collar of my T shirt before I could understand anything. He smelt alcohol badly from his mouth and started abusing and hitting dangerously and assaulted me physically which could have been lead to my death if some of my colleagues fortunately would have not reached on the spot by that time and some how managed to save my life. Police was called and the matter was discussed in the Township Police Station after receiving required treatment at our CPT hospital.

It is further to be noted that on the same day at around 2000 Hrs. when I was returning after collecting some milk and vegetables from Makhan babur bazaar with my kid by my scooter, three unknown young men riding a Enfield bike of black colour with no number plate at rear came to my scooter near CPT hospital and started abusing me badly and threatened to kill me. I have no other option but to keep quiet and proceed to my residence from the spot.

In view above I along with my family is very much suffering from mental trauma and risk of life and requesting kind attention from your good self for urgent necessary action in this regard please.
