Sir,

It is intimated that on dated 17.03.2017 at about 01.30 hrs a CISF river patrolling boat caught one mooring boat at HOJ- II and search the boat then it has found they brought 14 nos drums (10 drums is sled and 04 drums is open) of paint without permission, each drums 20 litter and cost per liter is 200/- Rs. The boat related from sponsoring firm of M/S JEDE ENGINEERING and Party Name CHANDAN MUKHUPADHYA, the boat wooden hal only authorized for tide of mooring the ship during arrival at the jetty. They not permitted for brought out any material or items from ship with out any permission but they illegal bring out 14 nos drums of paint from following accrued person at near by HOJ -II. The following under mention workers of M/S Jede Engineering involved in this case .
