

residing at vill +PO+PS= Durgachak, Dist. – Purba Medinipur, W.B. has been
forced to make this written complaint regarding missing of approximately
40.75 MT Bitumen VG-30 fully loaded in two tankers of below given
description.

Sir I am working as an employee and in charge of loading of Bitumen for my employer H.R. Builders here in IOC Haldia Refinery for sending/ transporting those towards its head office at Gopalganj, Bihar. In that Process two tanker supplied by M/S. Jai Ma Sherawali Transport have loaded approximately 40.75 MT on dated 23/03/2017 and 24/03/2017 from IOC Haldia Refinery, and

jointly started their journey from Haldia on dtd. 24/03/2017 at around 6 – 6.30 pm. Evening. After that when I was monitoring over phone upon these two vehicle through the drivers cellphone, today 26/03/2017, at about 10.30 am morning one driver, namely Dilip (of vehicle Reg. No.- WB23D 4526) informed me that he has already delivered/ released the said Bitumen in Kharagpur area as per the instructions given by their transporter M/S. Jai Ma Sherawali Transport Co. Whereas neither myself nor my office has never given such order/ instructions to them rather than they should reach to our Gopalganj, Bihar address in time.

Therefore, we have to force huge loss and damages if our Bitumen get lost.

Thus I have been forced to submit this written letter before you for proper investigation & justice. And I believe that you will be kind enough towards my problem and take necessary steps to solve the same.
