Sub: Prayer to lodge FIR

Sir.

In producing here with the following 04 (Four) arrested accused persons namely 1. Again Mallik (22 Yrs), S/O- Rahim of Vill - Bhagyamantapur, P.S-Durgachak, Dist.-Purba Medinipur 2. Sk. Sarian (19 Yrs), S/O- Lt. Sk. Anawar of Vill.- Bhagyamantapur, P.S-Durgachak, Dist.-Purba Medinipur 3. Bablu Manna (26 Yrs), S/O- Swapan Manna of Vill- Gandhinagar, P.S-Haldia, Dist.-Purba Medinipur 4. Prasenjit Dakua (21 Yrs), S/O- Narayan Dakua of Vill-Gandhinagar, P.S-Haldia, Dist.-Purba Medinipur, under arrest along with following seized articles i) One knife having wooden butt length approx 09 inches, recovered from the possession of Ajgar Mallik, ii) One iron Chopper/Vojali having wooden butt and approx 09 inches in length recovered from the possession of Sk. Sarian iii) One nylon rope length approx 20' recovered from Bablu Manna iv) 02 Iron cutter blade recovered from Prasenjit Dakua v) 06 Bamboo Sticks each of length about 5' and one iron made hammer having wooden butt from the PO at Tanki More, I S.I. Raju Kundu of Haldia P.S beg to report that on 04.04.2017 at about 22:35 hrs while I was performing night mobile duty at Haldia PS area with C/1376 Santi Ghosh, C/1068 Shaktimoy Chakraborty and C/400 Sonjay Biswas all of Haldia PS vide Haldia PS CC NO. 472/17 dt. 04.04.17, received information from the duty officer SI Manas Chatterjee that about 10 to 12 unknown miscreants have assembled near Tanki More under Haldia PS for committing dacoity in respect oil tanker. Accordingly, I consulted with I/C Haldia PS over telephone and as per his direction left for the P.O. to work out the information.

At 22.55 hrs we reached the place and then advanced towards the spot by foot very carefully. On reaching at the spot we found that about 10/12 unknown miscreants gossiping among them at Tanki More under Haldia PS in the darkness. On seeing the police party the miscreants tried to flee away but after a hot chase we managed to apprehend the above noted 04 (Four) accused persons but the other miscreants successfully managed to free away. On interrogation the apprehended persons disclosed their identity as noted above and stated that they have assembled at the P.O in order to commit dacoity in respect of oil tanker. On suspicion we searched them and recovered the above noted seized articles. Hence I arrested them after preparing proper arrest memo and took them in police custody at 23.15 hrs. I seized the above recovered articles from the possession of arrested accused persons after preparing the proper seizure list as well as labelled duly signed by the accused and police witnesses. Due to dead hours of night, no public witnesses were available at the P.O.

So, I therefore pray before you, kindly start a case against the above noted arrested accused persons and others <u>U/S-399/402 I.P.C</u> and arrange for its investigation.
