Sub:- Complaint for selling of I/D liquor without any license.

Sir.

In producing herewith accused persons namely 1). Nemai Das (45 yrs) son of Late Lakhan Chandra Das of Rayraynachak Ps Haldia Dist- Purba Medinipur, with the below noted seized items , I am to state that on 09.04.17 at about 06.45 hrs while , myself ASI Goutam Ray of Haldia Town Ship I/C under Haldia Ps along with C/ 134 Swapan Pramanik and C/- 646 Radhanath Pradhan all of Haldia Township I/C under Haldia PS were in patrolling against crime and criminals at Ramgopalchak areas under Haldia PS at that time received a credible source information that one person named Nemai Das was running a business of selling of I/D liquor without any license from his shop situated at Rayraynachak under Haldia P.S. So to pursue the information I along with force left for Rayraynachak. On reaching the said place I found that one person was selling liquors to the different customers. On seeing police all tried to run away but we managed to apprehend the sellers of the liquor who was selling liquors from his shop On asking his name, his name was known as Nemai Das (45 yrs) son of Late Lakhan Chandra Das of Rayraynachak Ps Haldia Dist-Purba Medinipur. On search at his shop the below noted I/D liquors were found. On enquiry it was known that he was conducting the business of selling of liquor without any license. On demand he failed to produce any license for stock and selling of the I/D liquors. I tried to find independent witnesses but none came forward to witnesses the search and seizure so the below noted quantity of liquors were seized from his shop under proper the seizure list only before police witnesses in between 07.35 hrs to 07.45 hrs and also arrested him at 07.35 hrs.

Description of the seized items:-1) I/D liquor contained in one 05Lts plastic Jarican containing approximately 05 Lts of I/D Liquor.

I also took 375 ml of seized liquor in one bottle from the above mentioned category as sample.

I arrested Nemai Das (45 yrs) son of Late Lakhar. Chandra Das of Rayraynachak Ps Haldia Dist- Purba Medinipur at about 19.25 hrs for selling of I/D liquors and on return to PS I submit this complaint to start case against him under proper section of law. During his arrest and search/seizure, I observed all arrest and search/seizure rules.
