

Subject: ROAD ACCIDENT AK MAITI, P/NVK(STD), P.No. 02758-T

Sir,

- It is brought to your notice that AK Maiti, P/Nvk(STD), P.No. 2758-T is a Service Personnel of Indian Coast Guard and presently posted at this headquarters. The above mentioned service personnel met with a road accident at around 1255 Hrs on 30 Dec 16, while travelling on bicycle at the junction of road connecting KV school, Haldia with main highway (Cluster-17).
- 2. AK Maiti, P/Nvk(STD), 02758-T was hit by a private bus and fell on the road side with injury on head and shoulder. Soon the local people gathered near him and he was also noticed by another Coast Guard Personnel P Bhattacharya, P/Ytk(ER), P.No. 08324-T. Blood was oozing from the head of casualty and he was groaning in pain. It was learnt from the gathered crowd that "Kwaza Baba" was written on the rear side of the private bus which lead to road accident. He was taken in a personal vehicle of one Coast Guard service personnel for medical check-up at MI-Room, Vikram Enclave (Cluster-18). He was later shifted to BC Roy Hospital for thorough check-up. The doctor at BC Roy, hospital intimated that patient's shoulder was dislocated and recommended CT-scan for further treatment. The patient was stabilized by providing first-aid and thereafter shifted to Command Hospital, Kolkata on same day for necessary treatment. AK Maiti, P/Nvk(STD), 02758-T is presently admitted at Command Hospital, Kolkata and his wife is also at Kolkata for taking care of her husband.
