Sub: Prayer to lodge FIR

Sir.

In producing here with the following 04 (Four) arrested accused persons namely 1. Sk. Akbar Ali (36Yrs), S/O- Lt. Sk. Kawsar Ali of Vill.- Anan Nagar 2. Sk. Israfil Ali (22 Yrs), S/O-Sk. Jalal of Vill- Gajipur 3. Sk. Faruk (20 Yrs), S/O- Sk. Nijam of Vill- Mohanpur 4. Sk. Masud (19 Yrs), S/O- Sk. Rabibul of Vill- Mohanpur all of PS- Sutahata, Dist.- Purba Medinipur, under arrest along with following seized articles i) One iron made improvised country made Pipe Gun (length 1'1" approx having wooden butt, barrel, trigger, firing pin etc) loaded with one 8 mm ammunition, recovered from the possession of Sk. Akbar Ali, ii) One iron Chopper/Vojali having wooden butt and approx 09 inches in length recovered from the possession of Sk. Israfil Ali iii) 05 pieces of bamboo lathi length about 3'6" each recovered from the P.O i.e beneath the Vidyasagar over bridge near IOC Main Gate, I A.S.I. Pradip Maity of Haldia P.S beg to report that on 16.12.2016 at about 23:15 hrs while I was performing night mobile duty at Haldia PS area with C/400 Sanjoy Biswas, C/256 Tulsi Kumar Das and C/916 Sitaram Mahato all of Haldia PS vide Haldia PS CC NO. 2316/16 dt. 16.12.16, received secret source information that about 10 to 12 unknown miscreants have assembled near Vidyasagar over bridge on the way to I.O.C. main gate for committing dacoity in respect of oil and bitumen trucks. Accordingly, I consulted with I/C Haldia PS over telephone and as per his direction left for the P.O. to work out the information.

At 23.35 hrs we reached the place and then advanced towards the spot by foot very carefully. On reaching at the spot we found that about 10/12 unknown miscreants gossiping among them at Vidyasagar over bridge in the darkness. On seeing the police party the miscreants tried to flee away but after a hot chase we managed to apprehend the above noted 04 (Four) accused persons but the other miscreants successfully managed to flee away. On interrogation the apprehended persons disclosed their identity as noted above and stated that, they have assembled at the P.O in order to commit dacoity in respect of oil and bitumen trucks. On suspicion we searched them and recovered the above noted seized articles. On further interrogation they confessed their guilt and stated that they along with Sk. Ajgar, S/O- Sk. Jamal of Vill- Mohanpur, PS- Sutahata, Dist. Purba Medinipur and other 06 (Six) persons assembled at the P.O and preparing for committing dacoity in respect of oil and bitumen trucks. So, I arrested them after preparing proper arrest memo and took them in police custody. I seized the above recovered articles from the possession of arrested accused persons after preparing the proper seizure list as well as labelled duly signed by the accused and police witnesses, as due to dead hours of night, no public witnesses were available at the P.O.

So, I therefore pray before you, kindly start a case against the above noted arrested accused persons and others, <u>U/S- 399/402 I.P.C and 25/27/35 Arms Act</u> and arrange for its investigation.
