Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Susanta Kr Dey, S/O - Lt Khagendranath Dey, about age 52 years a permanent resident of Vill-Kamarput, P.O -Junput, P.S -Junput Coastal, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.03.2017 at about 03.30 PM I, Sri Moumit Maji, A.E & SM Contai CCC S/O-Lt. Amalesh Maji along with Sri Himangshu Sekhar Maity, LM Contai CCC, Sri Sukhdeb Maity, LM Contai CCC had been to the village- Kamarput for routine inspection purpose. During inspection it was found that Sri Susanta Kr Dey was consuming electricity dishonestly in his Agricultural premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection Some portion of separated single core 3 nos(Three), one blue colour another one yellow and other white colour PVC coated 1100/660 V grade, 10 Sq mm aluminium conductor of length 2(Two) meter each approx. Use to run the agriculture pump motor set unauthori has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Susanta Kr Dey acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 04.00PM.

Thus the accused Sri Susanta Kr Dey, S/O - Lt Khagendranath Dey, Vill - Kamarput, P.O -Junput, , P.S -Junput Coastal, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain & treat it as FIR.
