Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Apurba @ Apu Maity, S/O - Lt. Kanailal Maity, a permanent resident of Village & P.O -Sarda P.S -Marishda, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 03.04.2017 at about 01.15 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO, both are of (S&LP), Contai Division Office along with Sri Moumit Maji, AE & SM, Contai CCC, Sri Sukhdeb Maity, LM Contai CCC and others had been to the village-Baguranjalpai PS- Junput Coastal for routine inspection purpose. During inspection it was found that Sri Apurba @ Apu Maity was consuming electricity dishonestly in his Commercial (fishery) premises consuming electricity unauthorisedly by way of direct hooking through 2 (two) core round shape black colour PVC coated 6 sq mm aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.88 KVA.

As theft of electricity was detected during inspection, the illegal hooking was dismantled and removed from the nearby LTOH line and some portion of 2 (two) core round shape black colour PVC coated 6 sq mm aluminium conductor of length 3 (two) meter approx alongwith hooking device were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Apurba @ Apu Maity acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01.45 PM.

Thus the accused Sri Apurba@Apu Maity, S/O - Lt. Kanailal Maity, a permanent resident of Village & P.O -Sarda P.S -Marishda, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complaint & treat it as FIR.
