beg to state that during the moving of Polling Party
from the debusing point at Nayapat Grampanchayat
office Asit Gai (aforesaid person and assaulter)
demanded me the Mobile no. of all presiding officers
under my Sector Area. But I want to know his
proper identity. He recognised himself as the
President of Trinamool Congress, Nayapat
Grampanchayat. Then and there he spoke abused
language. Further, he placed Swarna Adikary, Honble
Minister of Govt. of West Bengal. He also
wanted to talk with me but I refused it. Then
the assaulter pressed on my mouth and even he
pressed me in neck and took photos of both
Sector Officer and me. He repeatedly threatened
near about one hour. Every time I was speaking
him. Meanwhile I informed to the BDO, Contai-I. And
he assured me to help moving the parties (polling) and
then to come back to the BDO's office. Already
the Sector police did not reach at my venue after
recurrent information to him. This incident occurred
at about 2:45 PM. The Sector police did not reach
upto 4:30 PM when this application was being
written at the spot.

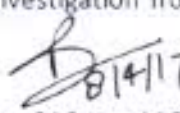

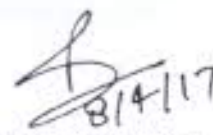
