I received a telephonic information from reliable source during my RT Mobile (evening) duty. After getting the source information myself along with force rushed at Purba Mohisagot found that the above noted person selling the Country Spirit to his grocery shop. On seeing Police party the customers are fled away but After chasing I apprehended Samar Patra (64) s/o- Satish, of Purba Mohisagot, PS- Junput Coastal Dist.- Purba Medinipur on interrogation he confessed that the above noted Country Spirit with his possession for sale. Accordingly, I told him to produced valid documents in support of that liquors but he failed to produce any valid documents in favor of that liquors. So, I taken him in custody and I seized 06(Six) bottles of sealed Sun Country Sprit, 600ml each bottle, total Worth Rs. 390/- with proper seizure list and labeled.

Under the above fact and circumstances, I therefore pray that a case may kindly be started u/s 46A(C) B.E. Act. against Samar Patra (64) s/o- Satish, of Purba Mohisagot, PS- Junput Coastal, Dist.- Purba Medinipur, PS- Junput Coastal Dist.- Purba Medinipur.
