Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Mukul Ranjan Maity, S/O - Sri Samaresh Maity, a permanent resident of Vill-Biswanathput, P.O -Dakshin Dauki, P.S -Junput Coastal, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 20.12.2016 at about 01:30 PM I, Sri Moumit Maji, AE & SM Contai CCC along with Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO, both are of (S&LP) unit of Contai Division Office, Sri Souvik Karar, OE, Contai CCC and others had been to the village Biswanathput for routine inspection purpose. During inspection it was found that Sri Mukul Ranjan Maity was consuming electricity dishonestly in his Domestic premises unauthorisedly through 2 (two) core, flat type 600/1100 volt grade 4 sq mm black colour PVC coated aluminium conductor by the way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.44 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 (two) core, flat type 600/1100 volt grade 4 sq mm black colour PVC coated aluminium conductor of length 2 (two) meter (approx) along with hooking device and one 3" x 4" switch board having one no 15 amp switch, one no 15 amp plug socket has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Mukul Ranjan Maity acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as Sri Mukul Ranjan Maity, S/O - Sri Samaresh Maity i.e. the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM

Thus the accused Sri Mukul Ranjan Maity, S/O - Sri Samaresh Maity, Vill - Biswanathput, P.O -Dakshin Dauki, , P.S -Junput Coastal, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
