Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Deb-Kumar Djha, S/O - Amalendu Ojha, a permanent resident of Vill- Baguranjalpai, P.O -Deshduttabar, P.S -Junput Coastal, Dist Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 28.02.2017 at about 12.30 PM I, Sri Manas Maity, A.E.(U) along with Sr. Pradipt Kumar Chakraborty, SO all are of (S&LP) Contai Division Cifice and Sri Himangshu Sekhar Maity, LM Contai CCC, Sri Sukadeb Maity, LM Contai CCC, Sri Souvik Karar, OE Contai CCC and others had been to the village- Baguranjalpai for routine inspection purpose. During inspection it was ound that Sri Deb Kumar Ojha was consuming electricity dishonestly in his Commercial (Fishery) premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 (two) core round shape black colour PVC coated 6 sq mm aluminium conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking was dismantled & removed from the nearby LTOH line of WE SEDCL and some portion of 2 (two) core round shape black colour PVC coated 6 sq min aluminium conductor of length 2 (1 vo) meter approx alongwith hooking device as a sample used to run the electrical pumpmotor set unauthorisedly for commercial (fishery) purpose were seized under memo of seizure list in the presence of the consumer and witnesses and their signature is also duly obtained in the seizure list Sr. Deb Kumar Ojha acknowledged the same by putting his signature in the Seizure List, Inspection Report, The above seized materials duly packed and labeled at the inspection site and signature of the WESEDCL representative as well as the of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:00 PM.

Thus the accused Sri Deb Kumar Ojha, S/O - Amalendu Ojha, Vill - Baguranialpai. P.O -Deshduttabar, , P.S - Junput Coastal , Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
