Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Gour Sankar Shit, S/O - Hrishikesh Shit, a permanent resident of Vill-Baguranjalpai, P.O -Deshduttabar, P.S -Junput Coastal, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 02.03.2017 at about 12.30 PM I, Sri Moumit Maji, AE & SM Contai CCC along with and Sri Himangshu Sekhar Maity, LM Contai CCC, Sri Sukhdeb Maity, LM Contai CCC and others had been to the village- Baguranjalpai for routine inspection purpose. During inspection it was found that Sri Gour Sankar Shit, S/O - Hrishikesh Shit was consuming electricity dishonestly in his Commercial (Fishery) premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 (two) core flat type black colour PVC coated 4 sq mm aluminium conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking was dismantled & removed from the nearby LTOH line of WBSEDCL and some portion of 2 (two) core flat type black colour PVC coated 4 sq mm aluminium conductor of length 2 (two) meter approx alongwith hooking device as a sample used to run the electrical pump-motor set unauthorisedly for commercial (fishery) purpose were seized under memo of seizure list in the presence of the consumer and witnesses and their signature is also duly obtained in the seizure list. Sri Gour Sankar Shit, S/O - Hrishikesh Shit refused to sign in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:00 PM.

Thus the accused Sri Gour Sankar Shit, S/O - Hrishikesh Shit, Vill - Baguranjalpai, P.O -Deshduttabar, P.S -Junput Coastal, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complaint treating it as FIR.
