Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Asamanja Mandal, S/O - Lt. Anil Mandal, a permanent resident of Vill-Raghusardarbar, P.O -Deshduttabar, P.S -Junput Coastal, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.03.2017 at about 2.30 PM I, Sri Moumit Maji, A.E & SM Contai CCC, S/O-Lt. Amalsh Maji along with Sri Himangshu Sekhar Maity, LM Contai CCC, Sri Sukhdeb Maity, LM Contai CCC had been to the village- Raghusardarbar for routine inspection purpose. During inspection it was found that Sri Asamanja Mandal was consuming electricity dishonestly in his Agricultural premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection Some portion of separated single core 3 nos(Three), one red colour another one yellow and other white colour PVC coated 1100/660 V grade, 16 Sq mm aluminium conductor of length 1.5 meter each approx along with hooking device. Use to run the agriculture purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Asamanja Mandal acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 3.00 PM.

Thus the accused Sri Asamanja Mandal, S/O - Lt. Anil Mandal, Vill - Raghusardarbar, P.O -Deshduttabar, , P.S -Junput Coastal, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain & treat it as FIR.
