In producing herewith arrested accused person namely Srimatya Chaya Rani Maji (55 yrs) W/o La. Rabin Maji of village Amalhanda, P.S. Kolaghat, Dist- Purba Medinipur with seized articles 03 (three) liters of I/D Liquor in one plastic Jaricane as per seizure list and relevant documents:

I ASI Shyamalendu Chowdhury attached with Kolaghat P.S. Dist-Purba Medinipur do hereby lodged a complaint against the above noted female accused person to the effect that on 27 03:17 at 14:05 hrs myself along with force Const-690 Kali Sankar Mondal, Const-1266 Aswini Kr. Khan and Lady Constable- 49 Santoshi Tamang all of Kolaghat P.S, vide GDE No.-1460 dt. 27.03.17 and C.C No.- 1338 dt. 27.03.17 were engaged for performing morning patrolling duty under Kolaghat PS area. During this duty at about 16.45 hrs myself received information from an unknown caller that one female person is selling I/D liquor from her house at village Amalhanda under Kolaghat P.S. On receiving such information myself along with force had been to the above place to work out the said information. On reaching there at about 17.05 hrs myself found that above person is selling I/D liquor to the publics from her house at Amalhanda village under Kolaghat P.S. Then we are proceeding towards the person silently. On getting smell of arrival of police team the said female person tried to flee away from there but on a hot chase we are able to apprehend her while other customer flee away. On search we are found I/D liquor in a plastic laricane from her possession. Being asked she disclosed her identity as mentioned above. On demand she fails to produce any valid License, documents, Challan, in support of such I/D liquor. Accordingly, myself arrested her through lady constable and informed her ground of arrest and also issued memo of arrest. I have seized one plastic Jaricane containing 03 (three) Liters I/D liquor from her possession after preparing proper seizer list duly signed by the accompanied witnesses and the accused person also. I took sample from seized articles in a bottle and also labeled it. As the said female accused person is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So she is committed offence U/S 46 (A)(c) Bengal Excise Act of 1909. It is also learnt that the above noted female accused person selling ID liquor illegally and sell the same to the publics. The seized articles (I/D liquor) is approx worth of Rs. 180/-

Therefore I pray that a suitable case may kindly be initiated against accused person namely Srimatya Chaya Rani Maji (55 yrs) W/o Lt. Rabin Maji of Amalhanda, P.S- Kolaghat, Dist-Purba Medinipur under proper section of law.
