business from our stores all over West Bengal and across the nation
through our phone application. The ownership of such trademarks in our
name can be ascertained from the official records of the Trade Marks
Registry at Kolkata. For your ready reference Photostat true copies of the
registration certificate are enclosed and marked "A".

By virtue of registration of trademarks we are vested with exclusive
legal rights under Section 29 of the Trade Marks Act, 1999 and are
entitled to use and apply such trademarks to our business restraining
any third party from using or applying the same.

We learnt from our sources that some unscrupulous person has
started jewellery business with the trade mark and name "Anjali
Jewellers and Sons" from Regent Ashoka Complex, Kolaghat Natun
Bazar, School More. The said party is threatening to sell spurious
