Sir(s),

This is to inform you that my mother is the owner and occupier of a plot of land of 6 Bigha more or less, situated at A.D.S.R. office - Panikura, District Registration office, Tomruk, Mawza - Kshetrahat, Pathuria, J.L. No. 249, Police station - Kolaghat, Dist. - Purba Medinipore, West Bengal, India. comprised in c.s Plot No. 325, 337, 381, and R.S, L.R. Plot No. 542, under L.R Khatian No. 100, 35, by way of inheritance. The said land actually belongs to my maternal grandfather Late Kalipada Panda who purchased the said property by way of registered deed of sale.

My said grandfather died intestate leaving behind him my mother namely Parul Basu Mondal as his only legal heir. My step grandmother Chandana Panda (Ahu) produced a registered deed of gift in her favour registered before the Sub Register, Panikura in the year 1955 being dated 9/2/55 and claimed during his lifetime by way of said deed of gift my said grandfather gave the said entire (and) to her. When we came to know this fact we verified the registered deed and came to know that the signature of my said grandfather in the deed is false and claiming duplicate. The said accused persons forged the signature of my grandfather and claiming that she and her son Kartick Ch. Ahu are the owners of the land. Thus, she has committed fraud and cheating with us and they are now preventing us to enter into the land and threatening us with dire consequences.

my said mother namely Parul Bala Mondal executed a power of attorney in favour of me which was registered before the Register of Assurance, Kolkata and by way of the said power of attorney, I was empowered to do all acts, deeds and things in her name as she could have lawfully done in respect of the said property.

Under the circumstances I request your good self kindly to take necessary action in this regard by investigating into the matter and treat this written complaint as F.I.R and thereby render justice to me.
