Dear Sir,

I do hereby lodge complaint, empowered by the enabling transitional provision u/s 172 of I.E. act '2003 to the effect that Sk Jiyaur Rahaman S/O Lt. Sk. Saiyad Ali of Vill: Tahala, PO- Sagarbarh, Dist-Purba Medinipur had committed theft of electricity u/s 135-1(b) of the I.E. ACT'2003 read with amendment act 2007 as stated hereunder:

On 11/04/'17 at about 11.35 A.M. u/s along with technical Staffs Sk. Abdul Rouf, LM and Sk. Hasibul Ali, Sr.T.S.H. of Kolaghat CCC had reached to the Domestic premises of Sk Jiyaur Rahaman at Vill: Tahala, PO-Sagarbarh and found that the user Sk Jiyaur Rahaman is enjoying electricity dishonestly by means of direct hooking from nearby LT line bypassing the electric meter (Serial No- B2635427, Con Id-201124872) of WBSEDCL through single phase PVC copper wire (White colour) for Domestic purpose, causing loss of revenue of WBSEDCL. Total load inspected at the premises is to the tune of 1.1 KVA.

As theft of electricity was detected during inspection the portion of hooking device (White colour PVC copper wire 18ft approx in length) was seized in presence of the witnesses and their signature obtained on the seizure list. The above said hooking articles were duly packed, sealed and labeled at the inspection site and signature of the witnesses obtained on the sealing label. The inspection team left the premises at about 12.20 P.M. on the same date after disconnection of power supply to the said premises.

The accused Sk Jiyaur Rahaman has committed an offence U/S 135/1(b) of electricity act 2003 with amendment act 2007. Therefore you are requested to take cognizance of this complaint and treat it as F.I.R.
