Sir,

In producing herewith one arrested accused person namely Bablu Pare(40) S/O Lt Mukunda of village jashar, P.S. Kolaghat, District- Purba Medinipur and also seized 10(Ten) Ltrs. I/D liquor in a Jar-cane,

I ASI Subrata Dasgupta do hereby lodged a written complaint against the above noted accused, to the effect that today on (18/4/17) during my night mobile duty vide Kolaghaf B/H GDE no.496/17 dt. 19/04/17 received a source information at 00.45 hrs that someone is selling ID Liquor at a temporary shop at Kharichak Bridge . After a short while to work out the information myself along with C/1356Paritosh Mahato and C/ 675 Jafar Ali Khan of Kolaghat B/H vide Kolaghat B/H CCno—979/17 Dated 19/04/17 reached at Kharichak Bridge at 01.05 hrs and found the above noted person is selling I/D liquor at his temporary shop at Kharichakbridge with a medium size Jar-cane. Seeing police party the customars flee away but we apprehend the seller namely Bablu Pare (40) S/O Lt Mukunda of village Joshar, P.S.Kolaghat, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about the any valid documents or license of the said liquor contained in Jar-cane. On our interrogation the said person confessed that he is running his business since few months ago without any license or valid documents and the liquor contain in the jar cane is I/D liquor. Then I asked the local people to accompany us for search. But none could came forward. So, in presence of police witnesses search the temporary shop and seized.

- 1) One Jar-cane containing 10 (Ten) Ltrs I/D liquor worth RS 400/- (10X40/-=Rs 400/-) [Approximate]

under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) Ltr I/D liquor in a bottle from seized articles SL No-1 as test sample. I arrested Bablu Pore (40) S/O Lt Mukunda village joshar, P.S. Kolaghat District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally, maintaining all norms of honourable Apex court. Searched him well but found nothing without his W/A. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a cog case may kindly be started against the accused namely Bablu Pore (40) S/O Lt Mukunda Of Village Joshar P.S. Kolaghat ,District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
