Sir,

In producing herewith arrested accused person namely Haripada Maity @ Swapan(72)s/o Lt. Rakhal Ch. Maity of village Barbahala, PS Kolaghat , Dist-Purba Medinipur along with seized articles 09 liters of I/D Liquor in a plastic Jaricane as per seizure list and relevant documents.

I ASI Shyamalendu Chowdhury attached with Kolaghat Police Station District- Purba Medinipore do hereby lodged a complaint against the above noted accused person to the effect that on 18/19.04.17 at about 07.15 hrs while myself along with force C/ 1313 Sk. Nazir Alam, C/438 Sarbani Sankar Mahapatra, C/653 Monoj Kr. Ghorai all of Kolaghat P.S , vide C.C no 2058/17 dt 18.04.17 and GDE NO.-922 dt.18.04.17 were performing R.T mobile duty Kolaghat PS area. During this duty, an information is received from a unknown caller about selling of I/D liquor by one person from one vacant place under Bus Pool at Kakdihi under Kolaghat P.S. On receiving such information, myself along with force had been to Kakdihi to workout the information. On reaching the P.O at about 07.10 hrs we found that the above noted accused person is selling I/D liquor to the publics. We try contacted with local public and they agreed to help police . On getting the scent of arrival of police party the said accused tried to flee away from there but on a hot chase we managed to apprehend him. On asked he disclosed his identity as mentioned above. On demand he fails to produce any valid License, documents, Challan, in support of selling I/D liquor. Accordingly I seized approx 09 Liters I/D liquor from his possession after preparing proper seizer list duly signed by the witnesses as wel as Police persons and the accused person. I took sample from seized articles and also labeled it. As the said accused person is running such type of clandestine business without obeying the provision of the Bengal Excise Act. He is committed offence U/S 46 (A)(c) Bengal Escise Act of 1909. So I arrested the above noted accused person and informed him ground of arrest and also issued memo of arrest. It is also learnt that the above noted accused person selling ID liquor illegally and sell the same to the publics. The seized articles approximate value of Rs. 900/-.

Therefore I pray that a suitable case may kindly be initiated against the above noted accused person under proper section of law.
