In producing herewith arrested accused person namely Sk. Mujibul (38 yrs) S/o Sk. Sher Ali Khan of village Sardabasan, PS Kolaghat, Dist-Purba Medinipur along with seized articles 10 (ten) litters of I/D Liquor in one plastic Jaricane as per seizure list and relevant documents.

I ASI Bibekananda Chatterjee attached with Kolaghat Police Station District- Purba Medinipore do hereby lodged a complaint against the above noted accused person to the effect that on 18.04.17 at 22.05 hrs myself along with force C/ 1189 Ashok Paricha, C/ 1434 Banshidhar Tarai and C/ 622 Durjodhan Manna all of Kolaghat P.S , vide C.C no 2056/17 dt 18.04.17 and GDE NO.-922 dt.18.04.17 were engaged for performing Night mobile duty under Kolaghat PS area. During this duty at about 05.30 hrs early morning received information from an unknown caller about selling of I/D liquor by one person at Bhogpur village behind the Gramin Bikash Bank under Kolaghat P.S. On receiving such information, myself along with force had been to Bhogpur to workout the said information. On reaching the P.O at about 06.05 hrs we are found that the above noted accused person is selling I/D liquor to the publics. Then we are proceeding towards the person silently. On getting smell of arrival of police team the said person tried to flee away from there but on a hot chase we are able to apprehend him while other customer flee away. On search we are found I/D liquor in a plastic Jaricane from his possession. Being asked he the apprehended person disclosed his identity as mentioned above. On demand he fails to produce any valid License, documents, Challan, in support of such I/D liquor. Accordingly myself seized one plastic Jaricane containing 10 (ten) Liters I/D liquor from his possession after preparing proper seizer list duly signed by the accompanied witnesses and the accused person also. I took sample from seized article in a bottle and also labeled it. Then, myself arrested him and informed him ground of arrest and also issued memo of arrest. As the said accused person is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So he is committed offence U/S 46 (A)(c) Bengal Excise Act of 1909. It is also learnt that the above noted accused person selling ID liquor illegally and sell the same to the publics. The seized articles (I/D liquor) is approx worth of Rs. 600/-

Therefore I pray that a suitable case may kindly be initiated against accused person namely Sk. Mujibul (38 yrs) S/o Sk. Sher Ali Khan of village Sardabasan, PS Kolaghat, Dist-Purba Medinipur under proper section of law.
