Sir,

In producing herewith one arrested accused person namely Basudev Das (32) S/O Harekrishna Das of Amalhandra, P.S-Kolaghat, Dist. Purba Medinipur and also seized 10 (Ten) ltrs ID liquor, 1 SI Nirapada Dolai do hereby lodged written complaint against the above noted accused, to the effect that on 03.06.17 at about 05 hrs during last hour of night patrolling duty vide Kolaghat B/H GDE NO 81 & Vide C.C No-112 dt 03.06.17 received source information that someone is carrying ID liquor within TOTO three wheeler vehicle for selling the same to different places of Kola village. After receiving this information myself along with C/37 Asto Bairy and C/675 Jafar Ali Khan reached at Cinema More at 20 hrs and found the above noted person is carrying ID liquor in his TOTO (three wheeler vehicle) having no Registration No & Paper to sell it different temporary shops of Kola village. Seeing the police party the carrier of the ID liquor tried to fled away with his TOTO (three wheeler vehicle) containing a ID liquor in a white colour plastic jar. Myself along with force chased the TOTO and failed to apprehend the carrier namely Basudev Das (32) S/O Harekrishna Das of Amalhandra, P.S. Kolaghat, Dist.-Purba Medinipur. Accordingly my-self along with forces detained the said person and I asked the local people to accompany us for search. But none could come forward. So in presence of police witnesses myself allowed him to search me after that myself searched his TOTO and found that a white colour plastic jar containing ID liquor which are noted below.

- 1 One Jar-cane containing 10 (Ten) Ltrs I/D liquor worth RS 400/- (10X40/-=Rs 400/-) [Approximate]

I asked Basudev Das about the any valid documents or license for carrying of the liquor and any paper of regarding possession of such quantity of liquor. On our interrogation confessed that he is running his business since few months ago without any license or valid documents. So, I seized the above noted articles under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) bottle from seized articles SI. No-1 as test sample and arrested the Basudev Das(32) S/O Harekrishna Das of Amalhandra, P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally, maintaining all norms of honourable Apex court. Searched him but found nothing without his W/A. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a specific case may kindly be started against the accused namely Basudev Das(32) S/O Harekrishna Das of Amalhandra, P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
